The number of Knights of this Order was limited by the original statutes to Thirty-eight, including the Sovereign. Extra Knights were, however, occasionally nominated, the first instance being in the case of Sir George Murray Keith, Ambassador at Copenhagen in 1772. In 1812 eleven extra Knights were nominated by an especial statute, and by a notification in the London Gazette, 2 Jan. 1815, the Order was still further extended, and divided into Three Classes, *viz.*

Knights GRAND CROSSES—Seventy-two, exclusive of the Sovereign and Princes of the Blood Royal.

Knights COMMANDERS—180, with power to the Sovereign to add thereto.

COMPANIONS—Number unlimited.

A List of this latter Class (as the Companions, though forming part of an Order of Knighthood, have not the rank of Knights) does not come within the plan of this work.
